

Footnotes:

- Footnote references should be inserted in the main text, starting with number¹,
- footnote references are inserted BEFORE the period ending a sentence,
- footnote font is Times New Roman, 10, single spacing,
- footnotes are inserted at the bottom of the page on which the thought quoted or referred to appears,
- the page (or the page range) in the publication to which the footnote relates is provided at the end of the footnote,
- footnotes are ended with a period,
- individual items within one footnote are separated by a semicolon,
- attention should be paid to correct punctuation.

Footnotes should be structured according to the following:**1. Footnote citation of a book by one of the authors:**

The author's last name and first name initial, *academic degree in italics*, place and year of publication, page/s.

E.g.

2. Footnote citation of a collective work:

Last name and first name initial of the author (of a given chapter), *title in italics* (of a given chapter), [in:] *publication title in italics*, ed./eds. (or scientific editor) first name initial and last name of the editor/s, place and year of publication, page/s.

E.g.

¹Lewicka-Strzałecka A., *Etyka biznesu jako dyscyplina naukowa*, [in:] *Etyka biznesu*, scientific editor J. Dietl, W. Gasparski, Warszawa 1999, p. 67.

3. Footnote citation of an article in a journal:

Author's last name and first name initial, *article title in italics*, „journal title in quotation marks” publication year, volume number (if available), page/s.

E.g.

¹Śliwiński B., *Kilka uwag o autorstwie Kroniki oliwskiej i opacie Stanisławie*, „Roczniki Historyczne” 2007, vol.73, p. 130.

4. Footnote citation of a periodical (quarterly, bimonthly, monthly journals):

Depending on the journal numbering used during the year, the number of the journal is provided before the page/s number/s, after the journal number (if the journal has no number, after the publication year).

E.g.

5. Footnote citations of websites must contain the date of last access.

E.g.

¹ <https://www.ssw-sopot.pl/> [accessed: 28.12.2018].

6. When the footnote refers to the same publication as the previous footnote, we Ibidem is used

E.g.

¹Słodczyk J., *Historia planowania i budowy miast*, Opole 2012, pp. 83-85.

²Ibidem, pp. 99-100.

7. If reference is made again to the same publication, but the preceding footnote refers to another publication, op. cit. is used

E.g.

8. When referring to different works by the same author, abbreviated version of the title (beginning of the title ...) is used.

E.g.
